- No issues reported in the update. Departments are working with their billing companies to run a report. Will follow up further with Carol Stream.
- Narcotic Records Justin
  - Justin reminded group and daily narcotic checks need to be completed on all vehicles daily, even those that are OOS or reserve. Group will continue to work with daily crews to ensure this is done.
  - Roselle requested a report writer report within ImageTrend to see narcotic checks. This is being worked on by ImageTrend with no clear date on release. Once release is made public this will be shared with EMS agencies.

## Paramedic Program Updates

- Progress of Class Tiffani
  - Tiff reports 15 students within the class. They have started ride time with the MSU and will start hospital clinicals shortly. Ride time requests will be sent to agencies in June for preceptors. Graduation will be in December.

## Region 8 Updates

- Reciprocity Justin
  - Region 8 is still working on the Regional System Entry test. Once test bank is complete, this will go to the Medical Directors for review and approval.
  - Region 8 has approved the E-Bridge forms for use. All EMS providers using E-Bridge will have the same forms
    - Glen Oaks will be going live in the future. Carol Stream and Glen Ellyn to be their test agencies.
    - Good Sam going live in August. Will trial with Lombard and Downers Grove. Once trail is complete our agencies will be able to send to Good Sam.

- iGel Feedback Dr. Graham / Group
  - Feedback from group is positive. Carol Stream stated there was some confusion on when to use and when not to use. This was addressed in house with no help needed from CDHEMSS.
  - Chris reports that the I-gel has been used 9 times on full arrest since go live. Time to airway has gone from 11.5 with ETT to 4.2 with i-gel. Will continue to watch outcomes and add data to agency monthly reports.
- IDPH CEMP Justin
  - Follow Up
    - CDHEMSS is complete with their submission for phase 1. There is 1 outstanding item and is being worked on with the agency. FCC licenses have been applied for by those in need with IDPH letters of support.
    - IDPH will perform a system inspection at a time TBD. The System will have 2-3 months' notice prior to arrival of IDPH. During the inspection IDPH will pull reports for QA, ECRN logs, ECRN calls, Narcotic records and visit an EMS agency. Additional items will be needed in the future for phase 2. Once this is known providers may be asked for more items.
  - Updated / Added System Policies
  - Additional policies and updates have been drafted to meet the requirements for the CEMP. These were included in the packets for agency review. Agencies have been asked to give feedback over the next 2 weeks. Once feedback is received a final draft will be sent to agencies prior to being implemented.
- Data Chris
  - System Data Reports
    - Chris shared the agency data reports. He asked that the agencies review their reports and give him feedback.
    - Chief B. Schultz asked if a repeat patient report can be added to the monthly reports. This would help guide their towns social workers to better assist their citizens.
